ANNOUNCEMENT: - Huddersfield Falcons MCC will organise a Centre Restricted Trial for solo motorcycles, held under the National Sporting Code, Standing Regulations of the ACU, the Yorkshire Centre Rules current at the time, the following Supplementary Regulations and any final instructions issued for the meeting.

ELIGIBILITY: - Restricted to registered members of Clubs affiliated to Yorkshire Centre ACU. All riders and passengers must hold a current ACU / SACU Trials Registration card or ACU/SACU competition licence. Any rider or passenger from another FMN MUST produce a licence issued by their FMN together with start permission and proof of personal accident Insurance. These <u>must</u> be available for inspection on request.

MACHINES: - Motorcycles as per NSC Appendix D Category 1, Group A1 Solos and TSR 8.

CLASSES: - Championship Route: - Expert, Intermediate and Novice

Clubman A Route: - Over 45 Experts, Over 45 Intermediate and Novice

Clubman B Route: - Novice

Any class of rider may choose to ride another route on a no-points basis.

Signing-on area will be clearly signed;

No Refreshments, toilet or re-fuelling facilities will be available.

No engines to be run before start time or until instructed.

COVID19 RESTRICTIONS: To allow the Club to maintain appropriate "Social Distancing" measures this Trial is open to a maximum of 100 riders. Should any entrant display any coronavirus symptoms, or be confirmed positive as part of the Test and Trace Programme, he / she should STAY HOME, along with anyone else in the same household or support bubble.

All online entries are subject to approval of the Club, and Competition Number will be confirmed prior to day of the event.

Only riders from the same household or "support bubble" should travel in the same vehicle. Parked vehicles must leave at least one clear space (minimum 2m) from other parked vehicles.

Signing-on will be way of each rider displaying his / her Competition Number to the Trials Secretary who will be seated within a vehicle displaying the Club name, Event Permit, Supplementary Regulations and other relevant Notices.

All Riders must practice "Social Distancing" when offloading / loading their vehicle, and whilst negotiating the course – only 3 riders allowed to inspect a section at one time, preferably using a "one-way walk-thro" system – no excessive waiting or queuing; if there are already 6 riders waiting to attempt a section move on to the next section to prevent lengthy queuing.

RIDERS DISOBEYING SOCIAL DISTANCE REQUIREMENTS IN ALL CASES WILL BE AUTOMATICALLY DISQUALIFIED AND MAY FACE FURTHER ACU DISCIPLINARY ACTION WITH SUSPENSION RECOMMENDED.

NO SPECTATORS WILL BE PERMITTED.

Do not return to this venue for practise purposes and **no** practising before or after the event.

ENTRIES: - Restricted to 100, but riders competing in the Yorkshire Centre Team Trial will be given priority.

Entries to be made via the ACU online events website <u>www.acu.org.uk</u> to include the correct fee by closing date of 20.00 hrs. on THURSDAY 27th. AUGUST.

IMPORTANT: There is provision on the online entry form for Competitors to state their 3 rider team entry in the Yorkshire Centre Team Trial, but they should ensure they are first authorised to do so by their individual Club.

PROTESTS: - as per the National Sporting Code of the ACU, section 10.04
