DATE: SUNDAY 21st . November 2021

ANNOUNCEMENT: - Huddersfield Falcon MCC will promote a Club Restricted Trial on the above date for solo motorcycles, held under the

current National Sporting Code, Standing Regulations of the ACU, the Yorkshire Centre Rules, the following Supplementary Regulations and any final instructions issued for the meeting.

**ELIGIBILITY:** - Restricted to registered members of Huddersfield Falcon MCC. All riders and passengers must hold a current ACU Trials Registration /Membership or a SACU licence or ACU/SACU rider's licence. Any rider or passenger from another FMN MUST produce a licence issued by their FMN together with start permission and proof of personal accident Insurance.

## COVID 19: Individuals need to take responsibility for their own safety and exercise judgement as appropriate.

The event will be run under the current recommendations issued by the Government and the ACU and must be adhered to. Anyone who has contracted coronavirus, exhibited symptoms, been in contact with someone who has been infected with the virus, or requested to self-isolate in a ten-day period prior to the event taking place shall not travel to or participate/officiate at the event and will follow Gov.UK guidance/advice as appropriate.

MACHINES: - Motorcycles as per NSC Appendix D Category 1, Group A1 Solos and TSR 8.

**CLASSES:** Experts, Intermediates, Novices, Beginners, T/Shock, O40's, O60's, Pre. 65 and Youth A, B, C & D. There will be 3 courses to choose from – Championship (Hard), Clubman A (50/50), Clubman B (Easy).

START / VENUE: - 11.00 a.m. at CATHOLES SPRING, COPTHURST MOOR, HOLMFIRTH, Nr. HUDDERSFIELD, HD9 2TS – at Junction of Linshaws Road, Cartworth Moor Road and White Gate Road - Lat. 53.541324 / Long. -1.8051966 (O/S Map Ref 110/130050)

No engines to be run before start time or until instructed.

## ENTRIES: - PRE-ENTRY ONLY VIA ACU ONLINE ENTRY SYSTEM www.acu.org.uk

CLOSING DATE FOR ENTRIES WILL BE 6.00pm ON SATURDAY 20th, NOVEMBER (NO ENTRIES WILL BE ACCEPTED ON THE DAY)

ENTRY FEE: - £16.00 Adults / £8.00 Youths 16 and under. (Note: A £3 Surcharge will be applied to entry cancelations on refunds). Plus, Falcon Club membership of £5\* for 2021 if not already paid, to be made electronically. At the time of entry, you will need to take out ACU Trial Registration / Licence if you haven't already done so (ONE DAY LICENCES WILL NOT BE AVAILABLE). \*Club Membership can also be paid online.

**RESULTS:** - Will be e-mailed to Competitors who provide an e-mail address, as well as being published on the Club's "Facebook" page and web site <a href="https://www.falconmcc.co.uk">www.falconmcc.co.uk</a> and other public domains.

**AWARDS:** the outright winner on each course will be awarded a £5.00 (equivalent) voucher on each trial, class winners will receive a £3.00 voucher; in both cases providing a minimum 3 riders take part. Other awards may be awarded at the Organiser's discretion.

NB. SOUVENIR TROPHY AWARDS PROVISIONALLY MAY BE MADE AT THE NEXT FALCON MCC DINNER & AWARDS EVENING IN EARLY 2022 (if Covid-19 restrictions allow).

**COURSE:** - All on private land and will generally be a minimum of 4 laps of eight or ten sections (to be decided on the day). There will be 3 courses to choose from – Hard, Clubman B (Easy) & Clubman A (50/50) - first section will close by 3.00pm at the latest by the Observer pulling out the course markers. Sections shall generally be ridden in correct order on each lap, subject to queuing qualification above. The onus on finding the sections is that of the competitor, the route will be clearly marked and should be closely followed.

**METHOD of MARKING: -** As per TSR 22b; stop NOT permitted. Ties will be resolved as per TSR 23. Failure to attempt a section will incur a 10 mark penalty in accordance with ACU Rules; alternatively you can incur a 5 mark penalty, but only if you request this off the Observer rather than attempt the section (this ruling applies to closed-to-club trials only).

To be classified as a finisher riders must attempt at least 75% of the sections.

PROTESTS: - Protests as per National Sporting Code of the ACU, section 10.04.

**GENERAL:** Please follow all signage and instructions. Failure to comply will result in you been asked to leave the venue.
