ANNOUNCEMENT: - Huddersfield Falcons MCC will organise a Centre Restricted Trial for solo motorcycles, held under the National Sporting Code, Standing Regulations of the ACU, the Yorkshire Centre Rules current at the time, the following Supplementary Regulations and any final instructions issued for the meeting. This event is a round of the ACU Yorkshire Centre Championship.

ELIGIBILITY: - Restricted to registered members of Clubs affiliated to Yorkshire Centre ACU. All riders and passengers must hold a current ACU Trials Registration /Membership or a SACU licence or ACU/SACU rider's licence. Any rider or passenger from another FMN MUST produce a licence issued by their FMN together with start permission and proof of personal accident Insurance.

These must be available for inspection on request

COVID 19: Individuals need to take responsibility for their own safety and exercise judgement as appropriate.

The event will be run under the current recommendations issued by the Government and the ACU, and must be adhered to.

Anyone who has contracted Coronavirus, exhibited symptoms, been in contact with someone who has been infected with the virus, or required to self-isolate prior to the event taking place shall not travel to or participate / officiate at the event and will follow Gov.UK guidance / advice as appropriate.

MACHINES: - Motorcycles as per NSC Appendix D Category 1, Group A1 Solos and TSR 8.

Clubman A Route: - Over 45 Experts, Over 45 Intermediate, Novice

Clubman B Route: - Novice

(Any class of rider may choose to ride another route on a non-competitive no-points basis)

ADULTS ONLY COURSE:- 3 laps (approximately 3 miles per lap) of 15 sections on private land which will be accessed partly by the use of public highway. ACU blanket single event Road Traffic Insurance is included within the entry fee, but **Machines & Riders must comply with RTA** and C & U requirements (see over) and sign a declaration to that effect.

METHOD of MARKING: - As per TSR 22b (No Stop). Ties will be resolved as per TSR 23 **PROTESTS:** - as per the National Sporting Code of the ACU, section 10.04

INSURANCE: As this event uses a small amount of Public Road motorcycles must have a valid motor insurance policy which provides as a minimum, Third Party Liability cover that complies with the Road Traffic Act. This can be either, by extending an existing motor policy to cover the event, or, by purchasing additional cover, providing under the Event Road Section Scheme as an adjunct to an existing motor policy. If a competitor has an extension to their existing policy, they will be required to sign a declaration that the cover complies with the requirements of the Road Traffic Act. Any responsibility for a fraudulent or misleading declaration about existing cover lies with the competitor. If a competitor wishes to add themselves to the Event Road Section cover offered via the organisers then they can do so prior to the event, providing they comply with the following:

- is aged 18 years or over
- has held a full motorcycle license for a minimum of 6 months
- has no more than 6 points on their driving license
- has had no more than 1 fault claim in the last 3 years and are named on a valid motor insurance policy for the motorcycle they are riding on the Event
- do not have the Third-Party Extension cover on their existing motorcycle policy
- the motorcycle has a valid MOT and taxed for the road, unless exempt from doing so

Any competitor who falls outside these parameters, must seek approval from the Appointed Insurance Broker prior to the event. Approval can be sought by sending an email to ABC Insurance Brokers Ltd. (via the ACU) and provide the Riders' name and date of birth, the date they past their full motorcycle test and details of any motoring claims and/or convictions. Additional cover provided by this scheme is only effective whilst the motorcycle is actively competing in the event and remains under the control or direction of the event organiser(s). Cover will cease immediately if you are precluded from starting, excluded or retire from the event.
