ANNOUNCEMENT: - Huddersfield Falcon MCC will promote a Club Restricted Trial on the above date for solo motorcycles, held under the current National Sporting Code, Standing Regulations of the ACU, the Yorkshire Centre Rules, the following Supplementary Regulations and any final instructions issued for the meeting.

ELIGIBILITY: - Restricted to registered members of Huddersfield Falcon MCC. All riders and passengers must hold a current ACU Trials Registration / Membership or a SACU licence or ACU/SACU rider's licence. Any rider or passenger from another FMN MUST produce a licence issued by their FMN together with start permission and proof of personal accident Insurance.

MACHINES: - Motorcycles as per NSC Appendix D Category 1, Group A1 Solos and TSR 8.
ELECTRIC bikes are welcome but entrants must be aware of the perceived fire risk attributed to these machines and must take necessary precautions to minimise the risk, including providing a standby Fire Extinguisher as recommended by the Bike or Battery Manufacturer (The Club will provide a Dry Powder extinguisher located adjacent to the signing-on vehicle)

CLASSES: Experts, Intermediates, Novices, Beginners, T/Shock, O40's, O60's, Pre. 65 and Youth A, B & C.
There will be 3 courses to choose from – Championship (Hard), Clubman A (50/50), Clubman B (Easy).

PRE-ENTRY ONLY VIA ACU ONLINE ENTRY SYSTEM www.acu.org.uk CLOSING DATE FOR ENTRIES WILL BE 8.00pm on FRIDAY 1st. AUGUST (NO ENTRIES WILL BE ACCEPTED ON THE DAY)

ENTRY FEE OF £20.00 / £15.00 (ADULTS / Youths 16 and under) , plus Falcon Club membership of £10* for 2025 if not already paid, to be made electronically. At the time of entry you will need to take out ACU Trial Registration / Licence if you haven't already done so (ONE DAY LICENCES WILL NOT BE AVAILABLE). *Club Membership can also be paid online.

Note PAID-UP CLUB MEMBERS CAN ONLY SCORE POINTS IN THE CLUB CHAMPIONSHIP SERIES

In the event of cancellation of event or a rider cancelling their entry the ACU will make a £3 surcharge for each rider entered via the ACU Event Entry System.

RESULTS: - Will be e-mailed to Competitors who provide an e-mail address, as well as being published on the Club's "Facebook" page and website www.falconmcc.co.uk and other public domains.

AWARDS: A generous cash award for the outright winner of the SERIES, plus awards for other course and class winners; providing a minimum 3 riders take part. Other awards may be awarded at the Organiser's discretion.
NB. SOUVENIR TROPHY AWARDS WILL BE MADE AT THE NEXT FALCON MCC DINNER & AWARDS EVENING IN EARLY 2026

COURSE: - All on private land and will generally be a minimum of 4 laps of 10 sections (to be decided on the day). There will be 3 courses to choose from – Hard, Clubman B (Easy) & Clubman A (50/50) - first section will close by 3.00pm at the latest by the Observer pulling out the course markers. Sections shall generally be ridden in correct order on each lap, subject to queuing qualification above. The onus on finding the sections is that of the competitor, the route will be clearly marked and should be closely followed.

METHOD of MARKING: - As per TSR 22b; stop NOT permitted. Ties will be resolved as per TSR 23. Failure to attempt a section will incur a 10 mark penalty in accordance with ACU Rules; alternatively you can incur a 5 mark penalty, but only if you request this off the Observer rather than attempt the section (this ruling applies to closed-to-club trials only).
To be classified as a finisher riders must attempt at least 75% of the sections.

PROTESTS: - Protests as per National Sporting Code of the ACU, section 10.04.

GENERAL: Please follow all signage and instructions. Failure to comply will result in you been asked to leave the venue.
Dogs must be kept on a lead. Please take your litter home
