SUPPLEMENTARY REGULATIONS FOR CLUB RESTRICTED EVENTS

DATE: Wednesday 25th. JUNE 2024

ANNOUNCEMENT: - Huddersfield Falcon MCC will promote a Club Restricted Trial for solo motorcycles, held under the National Sporting Code, Standing Regulations of the ACU, the Yorkshire Centre Rules current at the time, the following Supplementary Regulations and any final instructions issued for the meeting.

ELIGIBILITY: - Restricted to registered members of Huddersfield Falcon MCC. All riders and passengers must hold a current ACU Trials Registration / Membership or a SACU licence or ACU/SACU rider's licence. Any rider or passenger from another FMN MUST produce a licence issued by their FMN together with start permission and proof of personal accident Insurance. (Registrations will be checked at signing on)

MACHINES: - Motorcycles as per NSC Appendix D Category 1, Group A1 Solos and TSR 8.

ELECTRIC bikes are welcome but entrants must be aware of the perceived fire risk attributed to these machines and must take necessary precautions to minimise the risk, including providing a standby Fire Extinguisher as recommended by the Bike or Battery Manufacturer (The Club will provide a Dry Powder extinguisher located adjacent to the signing-on vehicle)

CLASSES: Experts, Intermediates, Novices, Beginners, T/Shock, O40's, Pre. 65 and Youth A, B, C & D.

There will be 4 courses to choose from – Hard, Clubman A (50/50), Clubman B (Easy), Plus a Dead Easy "GREEN ROUTE"

CLOSING DATE FOR ENTRIES WILL BE 8.00pm ON TUESDAY 24th JUNE (NO ENTRIES WILL BE ACCEPTED ON THE DAY)

ENTRY FEE OF £20.00 / £15.00 (ADULTS / Youths 16 and under), plus Falcon Club membership of £10* for 2025 if not already paid, to be made electronically. At the time of entry you will need to take out ACU Trial Registration / Licence if you haven't already done so (ONE DAY LICENCES WILL NOT BE AVAILABLE). *Club Membership can be paid online also

RESULTS: - Will be e-mailed to Competitors who provide an e-mail address, as well as being published on the Club's "Facebook" page and website www.falconmcc.co.uk (Results will also be published on ACU Website and on Trials Central).

AWARDS: Overall winner of this 3 Round Evening Series will be awarded the Wilf & Peggy Holland Summer Wine Trophy, and each Class winner will also receive an Award, subject to there being at least 3 competitors in each class - AWARDS TO BE MADE AT THE YEAR END.

COURSE: - All on private land and will generally be a minimum of 3 laps of eight sections (to be decided on the day). There will be 4 courses to choose from – **Hard, 50/50, Easy, Dead Easy**, with a course-closing time of 9.00pm at the latest.

Sections shall generally be ridden in correct order on each lap but the Secretary will advise you at the start which section your group of Riders should start from. The onus on finding the sections is that of the competitor, the route will be clearly marked and should be closely followed.

METHOD of MARKING: - As per TSR 22b; stop NOT permitted. Ties will be resolved as per TSR 23. Failure to attempt a section will incur a 10 mark penalty in accordance with ACU Rules; alternatively you can incur a 5 mark penalty, but only if you request this off the Observer rather than attempt the section – this ruling applies to closed-to-club trials only. To be classified as a finisher riders must attempt at least 75% of the sections.

PROTESTS: - as per the National Sporting Code of the ACU section 10.04.
