ANNOUNCEMENT: - **SUBJECT TO COVID19 RESTRICTIONS STILL APPLICABLE ON THE DAY OF THE TRIAL** Huddersfield Falcons MCC will organise a Centre Restricted Trial on Sunday 29th. August 2021 for solo motorcycles, held under the National Sporting Code, Standing Regulations of the ACU, the Yorkshire Centre Rules current at the time, the following Supplementary Regulations and any final instructions issued for the meeting

ELIGIBILITY: - Restricted to registered members of Clubs affiliated to Yorkshire Centre ACU. All riders and passengers must hold a current ACU / SACU Trials Registration card or ACU/SACU competition licence. Any rider or passenger from another FMN **MUST** produce a licence issued by their FMN together with start permission and proof of personal accident Insurance. These must be available for inspection on request.

MACHINES: - Motorcycles as per NSC Appendix D Category 1, Group A1 Solos and TSR 8.

CLASSES: -
Championship Route: - Expert, Intermediate and Novice
Clubman A Route: - Over 45 Experts, Over 45 Intermediate and Novice
Clubman B Route: - Novice
Any class of rider may choose to ride another route on a no-points basis.

START / VENUE: - 10.30 a.m. @ Moorfield Farm, Cartworth Moor Road, Holmfirth. HD9 2QS. Latitude: 53.55524, Longitude: -1.8011190
Signing-on area will be clearly signed; a refreshment van will be present but NO toilet or re-fuelling facilities.
No engines to be run before start time or until instructed.

Although all COVID19 RESTRICTIONS were lifted as from the 19th. July, the virus has not gone away and it is imperative that all who attend this event are mindful of that fact: Individuals need to take responsibility for their own safety and exercise judgement as appropriate. The event will be run under the current recommendations issued by the Government and the ACU and must be adhered to.

Anyone who has contracted coronavirus, exhibited symptoms, been in contact with someone who has been infected with the virus, or requested to self-isolate in a ten-day period prior to the event taking place shall not travel to or participate/officiate at the event and will follow Gov.UK guidance/advice as appropriate'.

All online entries are subject to approval of the Club, and Competition Number will be confirmed prior to day of the event.

Signing-on will be way of each rider displaying his / her Competition Number to the Trials Secretary who will be seated within a vehicle displaying the Club name, Event Permit, Supplementary Regulations and other relevant Notices.

It is recommended that All Riders practice "Social Distancing" when offloading / loading their vehicle, and whilst negotiating the course, particularly when inspecting sections, and preferably using a "one-way walk-thro" system with no excessive waiting or queuing; if there are already 6 riders waiting to attempt a section move on to the next section to prevent lengthy queuing.

ENTRIES: - Restricted to 120, but riders competing in the Yorkshire Centre Team Trial will be given priority.

IMPORTANT: There is provision on the online entry form for Competitors to state their 3 rider team entry in the Yorkshire Centre Team Trial, but they should ensure they are first authorised to do so by their individual Club.

ACU blanket single event Road Traffic Insurance is included within the entry fee, but **Machines & Riders must comply with RTA and C & U requirements, particularly with regard to having rearward facing legible number plates, and machines that are obviously not compliant will not be allowed to start (Registration numbers must be stated on the enclosed entry form).**

METHOD of MARKING: - As per TSR 22b (No Stop). Ties will be resolved as per TSR 23

PROTESTS: - as per the National Sporting Code of the ACU, section 10.04
